Teaching Methodology	<p>The course is delivered through three hours of lectures per week, which include presentation of new material and demonstration of concepts. Assessment	<p>The Students are assessed via continuous assessment throughout the duration of the Semester, which forms the Coursework grade and the final written exam. The coursework and the final exam grades are weighted 40% and 60%, respectively, and compose the final grade of the course.</p> <p>Various approaches are used for the continuous assessment of the students, such as class participation and in class exercises, assignments and tests. The assessment weight, date and time of each type of continuous assessment is being set at the beginning of the semester via the course outline. An indicative weighted continuous assessment of the course is shown below:</p>

	<ul style="list-style-type: none"> <li>• Participation Activities (4% of total marks for module)</li> <li>• Three assignments (20% of total marks for module)</li> <li>• One closed-book test (16% of total marks for module)</li> <li>• One closed-book, 2-hour exam (60% of total marks for module)</li> </ul> <p>Students are prepared for final exam, by revision on the matter taught, problem solving and concept testing and are also trained to be able to deal with time constraints and revision timetable.</p> <p>The criteria considered for the assessment of each type of the continuous assessment and the final exam of the course are: (i) the comprehension of the fundamental concepts and theory of each topic, (ii) the application of the theory in solving related problems and (iii) the ability to apply the above knowledge in complex real-life problems.</p> <p>The final assessment of the students is formative and summative and is assured to comply with the subject's expected learning outcomes and the quality of the course.</p>
